Practice Direction No. 3 of 1988

The Hon'ble the Chief Justice Malaya directs the following amendments be made to Practice Direction 7 of 1987 with effect from 6th June, 1988.

The Judge of the Appellate and Miscellaneous division shall have the following additional functions:-


- a) Supervise the Subordinate Courts of Selangor and the Federal Territory in respect of civil matters;
- b) Hear:-
 - i) Applications for short calls of chambering students;
 - ii) Petition for Admission & Enrolment as advocates and solicitors.

Supervision over Subordinate Courts in Selangor and the Federal Territory in criminal matters shall be exercised by Y.A. Dato' Annuar bin Dato' Zainal Abidin.

The Commercial Division shall comprise the following Judges:-

- ii. Y.A. Dato' V.C. George
- iii. Y.A. Dato' Dr. Zakaria bin Mohd. Yatim
- iv. Y.A. Dato' Siti Norma Yaakob.
