REGISTRAR'S CIRCULAR (U) NO. 6 OF 1979

Preparation of Appeal Records in  
Criminal Appeals to the Federal Court.

I am directed by the Hon'ble the Lord President to draw your attention to rule 8(1) of the Federal Court (Criminal Appeals) (Transitional) Rules, 1964 (L.N. 52 of 1964) which reads:

"8.(1) As soon as practicable after the filing of a Notice of Appeal in his Registry the Registrar of the High Court shall forward to the Registrar of the Court at Kuala Lumpur particulars of the appellant's trial in the Form C in the First Schedule hereto together with five copies of the following papers:

- (a) the trial Judge's note of the trial;
- (b) all documentary exhibits produced at the trial except such as are of so voluminous a nature that the copying thereof in the opinion of the Registrar of the High Court will cause undue delay;
- (c) where the trial has been with the aid of a jury or assessors a note (verbatim if available) of the charge or summing-up to the jury or assessors;
- (d) where the trial has been by a Judge alone any written judgment delivered by the trial Judge or where no such written judgment has been delivered a statement in writing by the trial Judge of the grounds of his decision;
- (e) a list of the exhibits at the trial."

2. It is noted that some appeal records do not contain the particulars in Form C as required by the rule.

3. Registrars are hereby directed to ensure that the particulars are included in the appeal records.

4. For easy reference, Form C is appended below (see Appendix "A").
