REGISTRAR'S CIRCULAR (A) 2 OF 1980

Translation Allowance

I am directed to draw your attention to Registrar's Circular (A) No: 3/79 dated 6th September, 1979, and wish to make the following amendments:-

(i) Para 11 should read as follows:-

"The fees must be paid in fully by stamps before the translation is transmitted to the appellant. (see L.N. 104 dated 27th March, 1958). The amount to which the office is entitled will then be drawn on a payment voucher from the Accountant-General's Office or its respective branches. (see Treasury Instructions, para 84)."

(ii) Substitute the word "Praecipe No." for "Receipt No." in paragraph 12.

2. In other words collection of translation fees should be by stamps and not cash.
