**PRACTICE DIRECTION OF THE CHIEF JUDGE OF
THE HIGH COURTS IN SABAH AND SARAWAK
NO. 1 OF 2018
ORAL SUBMISSION AND GROUNDS OF DECISION**

I respectfully refer to the above matter.

(A) Oral Submission in both Civil and Criminal Cases

2. For all contested civil cases and criminal cases pending hearing in all the subordinate courts and High Court in Sabah and Sarawak, the Honourable High Court Judges / Judicial Commissioners and Judicial Officers shall fix a date of hearing of an Oral Submission to be made by the counsel for the respective party on all salient points of facts, issues and laws of the case at hand on top of the written submissions which may have been filed by the counsel for respective party.

(B) Summary ground and full Ground of Decision in both Civil and Criminal Cases

3. In respect of an interlocutory application which is dismissed by the court, at least a summary / brief ground of decision shall be furnished by the court to the parties at the time of the delivery of the decision.

4. In respect of an interlocutory application which is allowed by the court, a summary / brief ground of decision shall be furnished to the parties at the time of the delivery of the decision followed by a full ground of decision to be furnished to the parties within one (1) month from the date of decision.

5. In respect of a decision made after trial in the court, a summary / brief ground of decision shall be furnished to the parties at the time of the delivery of the decision followed by a full ground of decision to be furnished to the parties within two (2) months from the date of the decision.

6. All the previous practice directions and/or circulars relating to grounds of judgment including the Registrar's Circular No. 2 of 2016 dated 5th August 2016 issued by the High Court in Sabah and Sarawak shall be superseded by this Practice Direction.

7. This directive shall take effect immediately.
